A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 10 of Title 43 of the Official Code of Georgia Annotated, relating to
2 cosmetologists, so as to provide and revise definitions of certain terms; to provide for
3 certificates of registration for master estheticians and for wax technicians at certain levels;
4 to authorize the State Board of Cosmetology to adopt rules and regulations prescribing
5 certain requirements for master estheticians and for schools of waxing; to provide a process
6 to obtain a wax technician certificate of registration; to allow certificates of registration to
7 be issued to master estheticians and wax technicians from other states under certain
8 circumstances; to provide certain residency requirements for certain applicants; to change
9 certain provisions relating to continuing education; to require that a certificate of completion
10 must be given to attendees at continuing education courses; to require that certain courses be
11 taught by certain schools; to provide requirements for teaching master estheticians and for
12 teaching waxing; to correct cross-references; to amend Chapter 7 of Title 43 of the Official
13 Code of Georgia Annotated, relating to barbers, so as to provide that a licensed barbershop
14 may employ a master esthetician or a wax technician without being required to be licensed
15 as a cosmetology shop or salon; to provide for related matters; to repeal conflicting laws; and
16 for other purposes.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

18 **SECTION 1.**

19 Chapter 10 of Title 43 of the Official Code of Georgia Annotated, relating to cosmetologists,
20 is amended as follows:

21 "CHAPTER 10

22 43-10-1.

23 As used in this chapter, the term:

24 (1) 'Beautician' means 'cosmetologist' as such term is defined in this Code section.

1 ~~(2) 'Beauty shop' or 'beauty salon' means any premises where one or more persons~~
 2 ~~engage in the occupation of cosmetology.~~

3 ~~(3)~~(2) 'Board' means the State Board of Cosmetology.

4 ~~(4)~~(3) 'Cosmetologist' means any person who performs any one or more of the following
 5 services for compensation:

6 (A) Cuts or dresses the hair;

7 (B) Gives facial or scalp massage or facial and scalp treatment with oils or creams and
 8 other preparations made for this purpose, either by hand or mechanical appliance;

9 (C) Singes and shampoos the hair, dyes the hair, or does permanent waving of the hair;

10 (D) Performs nail care, pedicure, or manicuring services as defined in paragraph (9)
 11 of this Code section; or

12 (E) Performs the services of an esthetician as defined in paragraph ~~(5)~~(6) of this Code
 13 section;

14 (F) Performs the services of a master esthetician as defined in paragraph (8.1) of this
 15 Code section; or

16 (G) Performs the services of a wax technician as defined in paragraph (15) of this Code
 17 section.

18 Such person shall be considered as practicing the occupation of a cosmetologist within
 19 the meaning of this Code section; provided, however, that such term shall not mean a
 20 person who only braids the hair by hairweaving; interlocking; twisting; plaiting;
 21 wrapping by hand, chemical, or mechanical devices; or using any natural or synthetic
 22 fiber for extensions to the hair, and no such person shall be subject to the provisions of
 23 this chapter. Such term shall not apply to a person whose activities are limited to the
 24 application of cosmetics which are marketed to individuals and are readily commercially
 25 available to consumers.

26 (4) 'Cosmetology' means the practice of the occupation of a cosmetologist as defined in
 27 paragraph (3) of this Code section.

28 (5) 'Cosmetology shop' or 'cosmetology salon' means any premises where one or more
 29 persons engage in the occupation of cosmetology.

30 ~~(5)~~(6) 'Esthetician' or 'esthetics operator' means a person who, for compensation, engages
 31 in any one or a combination of the following practices, esthetics, or cosmetic skin care:

32 (A) ~~Massaging the face or neck of a person~~ Cleansing, toning, performing effleurage,
 33 or other related movements;

34 (B) ~~Trimming eyebrows~~ Applying makeup or eyelashes to any person;

35 (C) Dyeing eyelashes or eyebrows; or

36 (D) ~~Waxing, stimulating, cleansing, or beautifying the face, neck, arms, or legs of a~~
 37 ~~person by any method with the aid of the hands or any mechanical or electrical~~

1 ~~apparatus or by the use of a cosmetic preparation~~ Stimulating, exfoliating, or
 2 performing any similar procedure on the skin of the human body, excluding the scalp
 3 area, by nonlaser device, by mechanical or electrical apparatus, by the use of cosmetic
 4 preparations for the care or improvement of the appearance of the skin, or by the use
 5 of a safety cartridge razor; or

6 (E) Performing the services of a wax technician.

7 Such practices of esthetics shall not include the diagnosis, treatment, or therapy of any
 8 dermatological condition. Such term shall not apply to a person whose activities are
 9 limited to the application of cosmetics which are marketed to individuals and are readily
 10 commercially available to consumers.

11 ~~(6) Reserved.~~

12 (7) 'Hair designer' means any person who performs any one or more of the following
 13 services for compensation:

14 (A) Cuts or dresses the hair; or

15 (B) Singes and shampoos the hair, ~~or dyes the hair,~~ or does permanent waving of the
 16 hair.

17 (8) 'Master cosmetologist' means a cosmetologist who is possessed of the requisite skill
 18 and knowledge to perform properly all the services mentioned in ~~paragraph (4)~~
 19 subparagraphs (A), (B), (C), (D), (E), and (G) of paragraph (3) of this Code section for
 20 compensation.

21 (8.1) 'Master esthetician' means any person who, for compensation, engages in any one
 22 or a combination of the following practices, esthetics, or cosmetic skin care:

23 (A) Performs the services of an esthetician as defined in paragraph (6) of this Code
 24 section;

25 (B) Microdermabrasion to the stratum corneum of the skin;

26 (C) Chemical exfoliation of the stratum corneum of the skin; or

27 (D) Light or other nonlaser device treatments limited to the stratum corneum of the
 28 skin.

29 Such practices of master esthetics shall not include the diagnosis, treatment, or therapy
 30 of any dermatological condition.

31 (9) 'Nail technician' means a person who, for compensation, trims, files, shapes,
 32 decorates, applies sculptured or ~~otherwise artificial nails~~ other artificial enhancements,
 33 or in any way cares for the nails of ~~another person~~ the hands or feet of another person.

34 (9.1) 'Safety cartridge razor' means a disposable razor which protects the skin from all
 35 but the very edge of the blade.

36 (10) 'School of cosmetology' means any establishment that receives compensation for
 37 training more than one person in the occupation of ~~cosmetology~~ cosmetologist as defined

1 in paragraph ~~(4)~~(3) of this Code section. Technical colleges whose programs have been
 2 approved by the Department of Technical and Adult Education or the Department of
 3 Education are not 'schools of cosmetology' within the meaning of this chapter; provided,
 4 however, that all such colleges and their programs shall be considered to be 'board
 5 approved.'

6 (11) 'School of esthetics' means any establishment that receives compensation for
 7 training more than one person in the occupation of ~~esthetics~~ esthetician as defined in
 8 paragraph ~~(5)~~(6) of this Code section. Technical colleges whose programs have been
 9 approved by the Department of Technical and Adult Education or the Department of
 10 Education are not 'schools of esthetics' within the meaning of this chapter; provided,
 11 however, that all such colleges and their programs shall be considered to be 'board
 12 approved.'

13 (12) ~~Reserved.~~

14 ~~(13)~~ 'School of hair design' means any establishment that receives compensation for
 15 training more than one person in the occupation of ~~hair design~~ a hair designer as defined
 16 in paragraph (7) of this Code section. Technical colleges whose programs have been
 17 approved by the Department of Technical and Adult Education or the Department of
 18 Education are not schools of hair design within the meaning of this chapter; provided,
 19 however, that all such colleges and their programs shall be considered to be 'board
 20 approved.'

21 (12.1) 'School of master esthetics' means any establishment that receives compensation
 22 for training more than one person in the occupation of master esthetician as defined in
 23 paragraph (8.1) of this Code section. Technical colleges whose programs have been
 24 approved by the Department of Technical and Adult Education or the Department of
 25 Education are not schools of master esthetics within the meaning of this chapter;
 26 provided, however, that all such colleges and their programs shall be considered to be
 27 'board approved.'

28 ~~(14)~~(13) 'School of nail care' means any establishment that receives compensation for
 29 training more than one person in the occupation of ~~nail care or manicuring~~ a nail
 30 technician as defined in paragraph (9) of this Code section. Technical colleges whose
 31 programs have been approved by the Department of Technical and Adult Education or
 32 the Department of Education are not 'schools of nail care' within the meaning of this
 33 chapter; provided, however, that all such colleges and their programs shall be considered
 34 to be 'board approved.'

35 (14) 'School of waxing' means any establishment that receives compensation for training
 36 more than one person in the occupation of a wax technician as defined in paragraph (15)
 37 of this Code section. Technical colleges whose programs have been approved by the

1 Department of Technical and Adult Education or the Department of Education are not
 2 schools of waxing within the meaning of this chapter; provided, however, that all such
 3 colleges and their programs shall be considered to be 'board approved.'

4 (15) 'Wax technician' means a person who for compensation removes hair using a
 5 physical wax depilatory, by tweezing, or using a safety cartridge razor.

6 43-10-2.

7 (a) There is created the State Board of Cosmetology. The board shall consist of nine
 8 members who shall be residents of this state. The board shall have the duty of carrying out
 9 and enforcing this chapter.

10 (b) Members of the board shall be at least 25 years of age and have obtained a high school
 11 diploma, a general educational development (GED) diploma, or a postsecondary education
 12 or college degree; and five of such members must have had at least five years of practical
 13 experience in the practice of cosmetology at the master level, a portion of which must have
 14 been as a ~~beauty salon~~ cosmetology shop or salon owner or manager. One member of the
 15 board must have had at least five years of practical experience in the practice of
 16 cosmetology at the esthetician level. One member of the board must have had at least five
 17 years of practical experience as a manicurist.

18 (c) The board shall meet as necessary each year for the purpose of adopting rules and
 19 regulations and handling other matters pertaining to duties of the board. Board members
 20 may attend and observe all written and practical examinations held for certificates of
 21 registration pursuant to this chapter.

22 (d) No member of the board shall be affiliated with any school of cosmetology. Two
 23 members shall not have any connection with the practice or business of cosmetology
 24 whatsoever but shall have a recognized interest in consumer affairs and in consumer
 25 protection concerns. No member of the board shall be affiliated or connected in any
 26 manner with any manufacturer or wholesale or jobbing house dealing with supplies sold
 27 to practitioners of cosmetology while in office.

28 (e) Board members shall be appointed by the Governor for a term of three years and until
 29 their successors are appointed and qualified. Vacancies shall be filled by the Governor for
 30 the unexpired portion of the term. The board may do all things necessary for carrying this
 31 chapter into effect and may, from time to time, promulgate necessary rules and regulations
 32 compatible with this chapter. The Governor may remove any board member for cause as
 33 provided in Code Section 43-1-17.

34 (f) Each year the members shall elect a ~~chairman~~ chairperson from among themselves. In
 35 the event the members cannot agree as to who shall be ~~chairman~~ chairperson, the Governor
 36 shall appoint one of such members as ~~chairman~~ chairperson. The ~~chairman~~ chairperson so

1 elected or appointed shall be eligible to succeed himself or herself. The members of the
2 board shall be considered public officers and shall take the oath required thereof.

3 (g) The board shall adopt a seal to be used to authenticate all its official papers and acts
4 and shall have power to subpoena witnesses, administer oaths, and hear and take testimony
5 in any matter over which it may have jurisdiction.

6 43-10-3.

7 Each member of the board shall be reimbursed as provided for in subsection (f) of Code
8 Section 43-1-2.

9 43-10-4.

10 Reserved.

11 43-10-5.

12 The division director shall keep a record of all proceedings of the board. Such records shall
13 be prima-facie evidence of all matters required to be kept therein, and certified copies of
14 the same or parts thereof shall be primary evidence of their contents. All such copies, other
15 documents, or certificates lawfully issued upon the authority of the board shall, when
16 authenticated under the seal of the board, be admitted in any investigation in any court or
17 elsewhere without further proof.

18 43-10-6.

19 (a) The board is authorized to adopt reasonable rules and regulations prescribing the
20 sanitary requirements of ~~beauty shops, beauty salons,~~ cosmetology shops, cosmetology
21 salons, schools of cosmetology, schools of master esthetics, schools of esthetics, schools
22 of hair design, ~~and~~ schools of nail care, and schools of waxing, subject to the approval of
23 the Department of Human Resources, to cause the rules and regulations or any subsequent
24 revisions to be in suitable form, and to transmit a copy thereof to the proprietor of each
25 ~~beauty shop, beauty salon~~ cosmetology shop, cosmetology salon, school of cosmetology,
26 school of master esthetics, school of esthetics, school of hair design, ~~or~~ school of nail care,
27 or school of waxing. It shall be the duty of every proprietor or person operating a ~~beauty~~
28 ~~shop,~~ cosmetology shop, cosmetology salon, school of cosmetology, school of master
29 esthetics, school of esthetics, school of hair design, ~~and~~ school of nail care, and school of
30 waxing in this state to keep a copy of such rules and regulations posted in a conspicuous
31 place in his or her business, so as to be easily read by his or her customers.

1 (b) The board is authorized to adopt reasonable rules and regulations requiring that persons
 2 licensed under this chapter undergo instruction on Human Immunodeficiency Virus and
 3 Acquired Immune Deficiency Syndrome.

4 (c) Any inspector employed by the division director shall have the power to enter and
 5 make reasonable examination of any ~~beauty~~ cosmetology shop, salon, and school in the
 6 state during business hours for the purpose of enforcing the rules and regulations of the
 7 board and for the purpose of ascertaining the sanitary conditions thereof.

8 (d) Any ~~beauty~~ cosmetology shop, salon, or school in which tools, appliances, and
 9 furnishings used therein are kept in an unclean and unsanitary condition so as to endanger
 10 health is declared to be a public nuisance.

11 43-10-7.

12 It shall be the duty of the board to issue through the division director those certificates of
 13 registration for which provision is made in this chapter.

14 43-10-8.

15 (a) It shall be unlawful for any person to pursue the occupation of cosmetology in this state
 16 unless he or she has first completed the required hours for and obtained the appropriate
 17 certificate of registration as provided in this chapter.

18 (b) It shall be unlawful for any person to hold himself or herself out as a master
 19 cosmetologist ~~or hair designer~~ without having first obtained the certificate of registration
 20 for such. Such person shall be authorized to perform all the services mentioned in
 21 paragraph ~~(4)~~(3) of Code Section 43-10-1. Nothing in this chapter shall prohibit any
 22 person who holds a valid master cosmetologist license in this state on March 29, 1983,
 23 from practicing at the master cosmetologist level as defined in paragraph ~~(4)~~(8) of Code
 24 Section 43-10-1.

25 (c) Reserved.

26 (d) Notwithstanding any other provisions of this chapter, any person desiring to perform
 27 solely hair ~~design~~ designer services shall be allowed to obtain a certificate of registration
 28 at the hair ~~design~~ designer level upon completing the required hours therefor, which
 29 certifies that the holder thereof shall be authorized to perform some or all of the services
 30 mentioned in paragraph (7) of Code Section 43-10-1.

31 (e) Notwithstanding any other provisions of this chapter, any person desiring to perform
 32 solely cosmetic skin care services shall be allowed to obtain a certificate of registration at
 33 the esthetician level upon completing the required hours therefor, which certifies that the
 34 holder thereof shall be authorized to perform some or all of the services mentioned in
 35 paragraph ~~(5)~~(6) of Code Section 43-10-1.

1 (f)(1) Notwithstanding any other provisions of this chapter, any person desiring to
 2 perform solely advanced cosmetic skin care services shall be allowed to obtain a
 3 certificate of registration at the master esthetician level upon completing the required
 4 hours therefor, which certifies that the holder thereof shall be authorized to perform some
 5 or all of the services mentioned in paragraph (8.1) of Code Section 43-10-1.

6 (g) Notwithstanding any other provisions of this chapter, any person desiring to perform
 7 solely cosmetic nail care services shall be allowed to obtain a certificate of registration at
 8 the nail technician level upon completing the required hours therefor, which certifies that
 9 the holder thereof shall be authorized to perform some or all of the services mentioned in
 10 paragraph ~~(6)~~(9) of Code Section 43-10-1.

11 (h) Notwithstanding any other provisions of this chapter, any person desiring to perform
 12 solely waxing services shall be allowed to obtain a certificate of registration at the wax
 13 technician level upon completing the required hours therefor, which certifies that the holder
 14 thereof shall be authorized to perform some or all of the services mentioned in paragraph
 15 (15) of Code Section 43-10-1.

16 ~~(2)~~(i) Notwithstanding any other provisions of this chapter, any person who has actively
 17 engaged in the practice of cosmetology, hair design, master esthetics, esthetics, ~~or~~ nail care,
 18 or waxing on a military installation in Georgia for three years prior to July 1, 1985, shall
 19 be eligible to receive a certificate of registration at the cosmetology, master esthetics, hair
 20 design, esthetics, ~~or~~ nail care, or waxing level upon proper proof of experience, application,
 21 and appropriate fee being submitted to the board on or before September 1, 1985.

22 ~~(g)~~(j) It shall also be unlawful for any person or persons to operate a ~~beauty shop, beauty~~
 23 ~~salon, hair design salon,~~ cosmetology shop or salon, school of cosmetology, school of
 24 master esthetics, school of hair design, school of esthetics, ~~or~~ school of nail care, or school
 25 of waxing without first having obtained a certificate of registration for such shop, salon,
 26 or school as provided in this chapter. Any ~~beauty~~ cosmetology shop, salon, or school shall
 27 register with the division director of the professional licensing boards prior to opening.

28 ~~(h)~~(k) This chapter shall have uniform application throughout the state so that no
 29 ~~cosmetologist, hair designer, beauty shop,~~ cosmetology shop or salon, school of
 30 cosmetology, school of master esthetics, school of hair design, school of esthetics, ~~or~~
 31 school of nail care, or school of waxing shall be exempt from regulation.

33 (a) Any person desiring to obtain a certificate of registration to enable him or her to engage
 34 in the occupation of cosmetology shall make application through the division director to
 35 the board and shall present proof that he or she has obtained a high school diploma, a
 36 general educational development (GED) diploma, or a postsecondary education or college

1 degree. If, after review of the application, it is determined that the applicant is at least 17
 2 years of age; has met the minimum educational requirements; is of good moral character;
 3 has completed a 1,500 credit hour study course with at least nine months at a board
 4 approved school or has served as an apprentice in a ~~beauty shop or beauty~~ cosmetology
 5 shop or cosmetology salon for a period of at least 3,000 credit hours; has practiced or
 6 studied the occupation of cosmetology; is possessed of the requisite skill in such
 7 occupation to perform properly all the duties of the occupation, including his or her ability
 8 in the preparation of tools, in performing the services mentioned in paragraph ~~(4)~~(3) of
 9 Code Section 43-10-1, and in all the duties and services incident thereto; and has passed
 10 both a written and a practical examination approved by the board, a certificate of
 11 registration shall be issued to him or her entitling him or her to practice the occupation of
 12 master cosmetologist. Notwithstanding any other provisions of this subsection, the board
 13 shall be authorized to waive any education requirements under this subsection in cases of
 14 hardship, disability, or illness or under such other circumstances as the board deems
 15 appropriate with respect to any applicant who was enrolled in a board approved school or
 16 had completed a board approved study course as of June 30, 2000.

17 (b) Should an applicant under this Code section fail to pass the written or the practical
 18 examination, the board shall furnish the applicant a statement in writing, stating wherein
 19 the applicant was deficient. Nothing in this chapter shall be construed to prevent applicants
 20 from making subsequent applications to qualify under this Code section, provided they
 21 again pay the required examination fee.

22 (c) An approved applicant for examination under this Code section may be issued a work
 23 permit authorizing said applicant to practice such occupation until the release of the results
 24 of the written and the practical examination for which the applicant is scheduled. If the
 25 applicant fails to appear for the examination or fails any portion of the examination, the
 26 work permit shall be revoked unless the applicant provides just cause to the board as to
 27 why the applicant was unable to appear for the examination.

28 (d) Should an applicant have a current cosmetology license in force from another state or
 29 country, or territory of the United States, or the District of Columbia, where similar
 30 reciprocity is extended to this state and licensure requirements are substantially equal to
 31 those in this state, be a legal resident of the United States, and ~~pays~~ have paid a fee and
 32 ~~submits~~ have submitted an application, the applicant may be issued, without examination,
 33 a certificate of registration at the appropriate level, entitling the applicant to practice the
 34 occupation of cosmetology or the teaching of cosmetology at that level, unless the board,
 35 in its discretion, sees fit to require a written or a practical examination subject to the terms
 36 and provisions of this chapter. Notwithstanding any other provisions of this subsection,
 37 the board shall be authorized to waive any education or experience requirements applicable

1 to any person who holds a current license or certificate to practice cosmetology outside of
 2 this state and who desires to obtain a license or certificate at a level authorized under this
 3 Code section to practice at such level in this state in cases of hardship, disability, or illness
 4 or under such other circumstances as the board deems appropriate.

5 (e) ~~Reserved.~~

6 (f)(1) Any person desiring to obtain a certificate of registration to enable him or her to
 7 engage in the occupation of hair design shall make application through the division
 8 director and shall present proof that he or she has obtained a high school diploma, a
 9 general educational development (GED) diploma, or a postsecondary education or
 10 college degree. If, after review of the application, it is determined that the applicant is
 11 at least 17 years of age; has met the minimum educational requirements; is of good moral
 12 character; has completed a 1,325 credit hour study course with at least seven months at
 13 a board approved school or has served as an apprentice in a beauty cosmetology shop,
 14 beauty cosmetology salon, or hair design salon for a period of at least 2,650 credit hours;
 15 has practiced or studied the occupation of hair design; is possessed of the requisite skill
 16 in such occupation to perform properly all the duties of the occupation, including his or
 17 her ability in the preparation of tools, in performing the services mentioned in
 18 paragraph (7) of Code Section 43-10-1, and in all the duties and services incident thereto;
 19 and has passed both a written and a practical examination approved by the board, a
 20 certificate of registration shall be issued to him or her entitling him or her to practice the
 21 occupation of hair design. Notwithstanding any other provisions of this subsection, the
 22 board shall be authorized to waive any education requirements under this subsection in
 23 cases of hardship, disability, or illness or under such other circumstances as the board
 24 deems appropriate with respect to any applicant who was enrolled in a board approved
 25 school or had completed a board approved study course as of June 30, 2006.

26 (2) Should an applicant under this subsection fail to pass the written or the practical
 27 examination, the board shall furnish the applicant a statement in writing, stating in what
 28 manner the applicant was deficient. Nothing in this chapter shall be construed to prevent
 29 applicants from making subsequent applications to qualify under this subsection,
 30 provided they again pay the required examination fee.

31 (3) An approved applicant for examination under this subsection may be issued a work
 32 permit authorizing said applicant to practice such occupation until the release of the
 33 results of the written and the practical examination for which the applicant is scheduled.
 34 If the applicant fails to appear for the examination or fails any portion of the examination,
 35 the work permit shall be revoked unless the applicant provides just cause to the board as
 36 to why the applicant was unable to appear for the examination.

1 (4) Should an applicant have a current hair design license in force from another state,
 2 country, territory of the United States, or the District of Columbia, where similar
 3 reciprocity is extended to this state and licensure requirements are substantially equal to
 4 those in this state, be a legal resident of the United States, and have paid a fee and have
 5 submitted an application, the applicant may be issued, without examination, a certificate
 6 of registration at the appropriate level entitling him or her to practice the occupation of
 7 hair design or the teaching of hair design at that level, unless the board, in its discretion,
 8 sees fit to require a written or a practical examination subject to the terms and provisions
 9 of this chapter. Notwithstanding any other provisions of this subsection, the board shall
 10 be authorized to waive any education or experience requirements applicable to any person
 11 who holds a current license or certificate to practice hair design outside of this state and
 12 who desires to obtain a license or certificate at a level authorized under this subsection
 13 to practice at such level in this state in cases of hardship, disability, or illness or under
 14 such other circumstances as the board deems appropriate.

15 ~~(g)~~(f)(1) Any person desiring to obtain a certificate of registration at the esthetician level
 16 under the terms of this chapter shall make application through the division director to the
 17 board and shall present proof that he or she has obtained a high school diploma, a general
 18 educational development (GED) diploma, or a postsecondary education or college degree.
 19 If, after review of the application, it is determined that the applicant is at least 17 years
 20 of age; has met the minimum educational requirements; is of good moral character; has
 21 completed a 1,000 credit hour study course of at least nine months at a board approved

10 (iii) Has one year of work experience at the master cosmetologist or the esthetician
11 level; and

12 (iv) Has passed both a written and a practical examination to become an instructor
13 in waxing.

14 (B) A person holding a current cosmetology license at the master cosmetologist or the
15 esthetician level who is a high school graduate, has a general educational development
16 (GED) diploma, or has a postsecondary education or college degree; who has
17 completed the required board approved hours of continuing education; and has board
18 approved work experience as an instructor or in education may, at the board's
19 discretion, be permitted to take the written and the practical examinations to become
20 an instructor at the wax technician level.

21 (7)(8) Any teacher or instructor shall renew his or her license to teach cosmetology at the
22 licensed level or to teach esthetics at the master esthetician level biennially in odd years
23 by remitting with his or her application a renewal fee in such amount as shall be set by
24 the board by regulation; provided, however, any teacher or instructor who fails to renew
25 his or her certificate of registration to practice as a cosmetologist, hair designer,
26 esthetician, or master esthetician, nail technician, or wax technician on or before the date
27 established by the board by regulation shall automatically have his or her license to teach
28 or instruct suspended. A person failing to renew his or her instructor's license within two
29 years after expiration shall be required to pay a reinstatement fee after board review.

30 (8)(9) Nothing in this Code section shall be construed as preventing a person from
31 obtaining a certificate of registration as teacher or instructor who is certified by the
32 Department of Education to teach cosmetology or to teach esthetics at the master
33 esthetician level in the state public schools. The certification is limited to those persons
34 who hold a current cosmetology license at the master cosmetologist level and also hold
35 a diploma or certificate of 1,500 credit hours from a board approved school and have
36 completed the three-year teachers training program required by the Department of
37 Education. Such persons shall also pass both a written and a practical examination

1 satisfactory to the board and, upon passage thereof, shall receive a license to teach
2 cosmetology.

3 (f) All teachers or instructors of cosmetology at all levels or of esthetics at the master
4 esthetician level seeking renewal of licenses are required to submit to the board proof of
5 completion of 15 hours of continuing education in the cosmetology profession approved
6 by the board at least half of which consists of instruction in teaching methods.

8 (a) The board shall have the right to set a course of study for all students of the schools of
9 cosmetology, schools of hair design, schools of esthetics, ~~and~~ schools of master esthetics,
10 schools of nail care, and schools of waxing within this state.

11 (b) Before a student shall be eligible to take the examination provided for in Code Section
12 43-10-9, he or she shall first file with his or her application for examination a transcript
13 showing the number of hours and courses completed from the school or shop attended by
14 the student.

16 (a) Nothing in this chapter shall prohibit any person at least 17 years of age from learning
17 the occupation of cosmetology under a master cosmetologist, provided that such
18 cosmetologist has had at least 36 months' experience and has held a certificate of a master
19 cosmetologist for at least 36 months. In addition, nothing in this chapter shall prohibit any
20 person at least 17 years of age from learning the occupation of cosmetology under an
21 instructor in a school of cosmetology who has been a cosmetologist for a period of at least
22 one year and has registered under this chapter. Nothing in this chapter shall prohibit any
23 person at least 17 years of age from learning the occupation of hair designer under a
24 cosmetologist holding a master cosmetologist certificate or a hair design certificate,
25 provided that such cosmetologist has had at least 36 months' experience or, under an
26 instructor in a school of cosmetology or school of hair design who has held a certificate as
27 a cosmetologist for a period of at least one year, is qualified to teach said practices and has
28 registered under this chapter. Nothing in this chapter shall prohibit any person at least 17
29 years of age from learning the occupation of esthetics under a cosmetologist holding a
30 master cosmetologist certificate or an esthetician certificate, provided that such
31 cosmetologist or esthetician has had at least 36 months' experience or, under an instructor
32 in a school of cosmetology or school of esthetics who has held a certificate as a
33 cosmetologist or esthetician for a period of at least one year, is qualified to teach said
34 practices and has registered under this chapter. Nothing in this chapter shall prohibit any
35 person at least 17 years of age from learning the occupation of master esthetics under a

1 master esthetician holding a master esthetician certificate, provided that such master
2 esthetician has had at least 36 months' experience or, under an instructor in a school of
3 cosmetology or school of master esthetics who has held a certificate as a master esthetician
4 for a period of at least one year, is qualified to teach said practices and has registered under
5 this chapter. Nothing in this chapter shall prohibit any person at least 17 years of age from
6 learning the occupation of nail care or manicuring under a cosmetologist holding a master
7 cosmetologist certificate or a nail technician certificate, provided that such cosmetologist
8 has had at least 36 months' experience or, under an instructor in a school of cosmetology
9 or school of nail care who has been a licensed cosmetologist for a period of at least one
10 year, is qualified to teach said practices and has registered under this chapter. Nothing in
11 this chapter shall prohibit any person at least 17 years of age from learning the occupation
12 of waxing under a cosmetologist holding a master cosmetologist certificate or an
13 esthetician certificate, provided that such cosmetologist or esthetician has had at least 36
14 months' experience or, under an instructor in a school of cosmetology or school of esthetics
15 who has held a certificate as a cosmetologist or esthetician for a period of at least one year,
16 is qualified to teach said practices and has registered under this chapter. Any person
17 registered as an apprentice under this Code section on June 30, 1997, shall be eligible to
18 continue such apprenticeship under the person from whom that apprentice was learning the
19 occupation of cosmetology, hair design, esthetics, or nail care or manicuring at the time of
20 registration notwithstanding that the person under whom the apprentice was learning such
21 occupation does not meet the 36 months' experience otherwise required by this Code
22 section. Every shop owner shall have the responsibility for registering apprentices with the
23 division director. The shop owner shall file a statement in writing, showing the
24 apprentice's name and the address of the shop. The board shall have the authority to
25 require the shop owner to furnish to the board the number of hours completed by the
26 apprentice. The shop owner shall remit to the division director a fee in such amount as
27 shall be set by the board by regulation for the registration of the apprentice. The apprentice
28 shall receive a certificate of registration showing the capacity in which he or she is
29 permitted to practice cosmetology. The certificate of registration shall be effective for a
30 period of two years and may be renewed at the end of such period upon the filing of an
31 application on forms furnished by the division director and the payment of a renewal fee
32 in such amount as shall be set by the board by regulation. A certificate of registration
33 authorizing a person to learn the occupation of cosmetology ~~under a cosmetologist~~ shall
34 not be renewed more than one time; and, upon the expiration of the last certificate of
35 registration issued, such person shall not be permitted to practice in any capacity.

5 (a) The board, acting upon its own knowledge or written or verified complaint filed by any
 6 person, shall have the power to reprimand or power to suspend, revoke, or cancel the

 9 any one of the following grounds:

 24 receiving written notification from either the board or a representative of the board unless
 25 the licensee requests in writing a hearing before the board. Such request for a hearing must
 26 be received by the board within 30 days after receipt of the written notification from the
 27 board. Failure either to pay the fine or request a hearing shall result in immediate

4 firm, or corporation, without being licensed or registered to do so by the board, engages in

6 which such person resides or, in the case of a firm or corporation, where the firm or

16 Notwithstanding any other provision of this chapter, a ~~beauty~~ cosmetology shop or salon
17 shall be authorized to employ persons to wash, shampoo, comb, and brush hair, and such
18 persons shall not be required to be registered by the board.

19 43-10-18.

20 (a) Nothing contained in this chapter nor any rule or regulation adopted in implementation
21 hereof shall be construed to prohibit any person from operating a ~~beauty~~ cosmetology shop
22 within his or her home or residence, provided that such shop meets and complies with all
23 of the provisions of this chapter and the rules and regulations promulgated by the board.

24 (b) It shall not be necessary for any person operating a ~~beauty~~ cosmetology shop in a
25 private home to post a sign denoting same to be a ~~beauty~~ cosmetology shop unless the
26 person elects to do so.

28 A ~~beauty~~ cosmetology shop or salon licensed under this chapter shall be authorized to
29 employ a barber licensed under Chapter 7 of this title. A ~~beauty~~ cosmetology shop or salon

31 title.

2 Notwithstanding any other provision of this chapter, premises made available for a ~~beauty~~
 3 cosmetology shop within a facility licensed as a nursing home pursuant to Article 1 of

 5 cosmetology shop under this chapter, or otherwise be subject to any provisions of this

18 (a) If any person not lawfully entitled to a certificate of registration under this chapter shall
 19 practice the occupation of a cosmetologist; or if any such person shall endeavor to learn the

 21 or other person, other than as provided in this chapter; or if any such person shall instruct
 22 or attempt to instruct any person in such trade; or if any proprietor of or person in control

 25 school of nail care, or school of waxing shall knowingly employ for the purpose of

 28 in this chapter though not registered under the provisions of this chapter; or if any person
 29 shall falsely or fraudulently pretend to be qualified under this chapter to practice or learn
 30 such trade or occupation; or if any person shall violate any provision of the chapter for
 31 which a penalty is not specifically provided, he or she shall be guilty of a misdemeanor.

32 (b) Any person who operates or manages a ~~beauty shop, salon~~ cosmetology shop or
 33 cosmetology salon, or school that employs a person who does not possess a license as
 34 provided in this chapter shall be guilty of a misdemeanor.

2 (a) For the purposes of this chapter, the teachers and instructors of and courses of
 3 instruction or training in cosmetology operated by the Department of Corrections shall be
 4 considered to be subject to the same standards and to be part of the cosmetology programs
 5 that are approved by the Department of Technical and Adult Education or the Department

19 Chapter 7 of Title 43 of the Official Code of Georgia Annotated, relating to barbers, is
 20 amended by revising Code Section 43-7-12.1, relating to authorization to employ
 21 cosmetologist, manicurist, esthetician, or shampooer without beauty shop license, as follows:

22 "43-7-12.1.

23 A barbershop licensed pursuant to this chapter shall be authorized to employ a
 24 cosmetologist, manicurist, esthetician, master esthetician, wax technician, or shampooer
 25 licensed under Chapter 10 of this title without that barbershop being required to be licensed
 26 as a beauty cosmetology shop or salon under Chapter 10 of this title."

27 **SECTION 3.**

28 All laws and parts of laws in conflict with this Act are repealed.
